

MINUTES OF MEETING OF BOARD OF DIRECTORS  
APRIL 2, 2025

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 132 §

The Board of Directors (the “Board”) of Harris County Municipal Utility District No. 132 (the “District”) met in special session, open to the public, at the Atascocita Waste Water Treatment Plant, 5003 Atascocita Road, Humble, TX 77346, and via teleconference, at 6:00 p.m. on April 2, 2025, whereupon the roll was called of the members of the Board, to-wit:

All members of the Board were present, along with Mr. Allen Jenkins of Inframark (“Inframark”), operator of the District’s facilities. Attending all or portions of the meeting by teleconference were Mr. Brian Humphrey of Humphrey Law PLLC, special counsel to the District; and Ms. Kathleen Ellison and Ms. Jane Maher of Norton Rose Fulbright US LLP (“NRF”), general counsel to the District.

**Call to Order.** The President called the meeting to order in accordance with notice posted pursuant to law, copies of certificates of posting of which are attached hereto as *Exhibit A*, and the following business was transacted:

1. **Public Comments.** There were no public comments.
2. **Executive session pursuant to Section 551.071 of the Open Meetings Act of the purpose of private consultation with the Board’s attorney about contemplated litigation and/or matters in which the attorney’s duty to the governmental body requires confidentiality under the Rules of Professional Conduct of the State Bar of Texas.** Ms. Ellison stated that this item is no longer needed.
3. **Return to open session.** The Board continued in open session.
4. **Authorize any desirable actions with respect to settlement discussions with Insurors Indemnity Company and/or proceeding with litigation against Insurors Indemnity Company.** The President recognized Mr. Humphrey, who provided an update on the Insurors Indemnity Company (“Insurors”) claim. He reported that Insurors initially offered to settle for payment in the amount of \$78,856.04 for coverage of the District’s completion costs. He stated the District also requested the payment of the \$78,000.00 for the economic disincentive fees provided in the contract. He reported that another demand letter was sent to Insurors stating that the Board would consider filing suit unless Insurors agreed to pay both the completion costs and the economic disincentive fees. He stated that Insurors responded and agreed to pay the total claim of \$156,856.04, which includes the economic disincentive fees. He recommended that the Board

consider accepting the offer. He noted that the formal settlement documents haven't been drafted yet, but recommended that the Board authorize the Board President to execute the settlement documents once provided.

Upon motion by Director Mielke seconded by Director Jackson, after full discussion and the question being put to the Board, the Board voted unanimously to accept the settlement offer from Insurors in the amount of \$156,856.04 and to authorize the Board President to execute the settlement documents, once provided and reviewed by counsel.

The Board thanked Mr. Humphrey for his work on the claim.


5. **Discuss operations issues, if any, and any necessary action.** Director Mielke and Director Whitaker reported on the meeting they had with representatives from Harris County Precinct 3 and BGE regarding the Golf Villas and Pinehurst Trail Drive Drainage. They stated that Harris County Precinct 3 acknowledged the problem with the drainage in this area and had some new ideas on how to address it. They said the Precinct also indicated an interest in contributing funds to a small project and could help with permitting. Director Whitaker said another meeting is scheduled. Discussion ensued.

Discussion ensued regarding the recent KHOU (TV) request for a statement regarding the District's rate increase.


THERE BEING NO FURTHER BUSINESS TO COME BEFORE THE BOARD, the meeting was adjourned.
